With reference to the captioned subject, we would like to inform you that the Subsidiary company Tangy Supplies & Solutions Private Limited (“the Subsidiary Company”) has received an order from the office of Commercial Tax Officer, Kundrathur, Tamil Nadu for an amount of Rs. 4,25,140/- under section 73.

Based on the Subsidiary company’s assessment, the order has been passed without considering the response which we have submitted against the notice. The Subsidiary company is in the process of exploring all legal options including filing appeal before the Appellant authority and the Subsidiary company is hopeful that there will be no significant financial impact in this case.
