Selvan (the "Complainant") filed a first information report dated March 17, 2022 (the "FIR") before the police station at Vepery, Chennai against several persons including our Chairman and Managing Director and Promoter, Raghunandana Tangirala alleging that he was wrongfully sold a property on April 11, 2007 at Okkiam Thoraipakkam village, Kancheepuram District, Chennai (the "Property"). It was further alleged that he was fraudulently sold the property by a representative of Harish Mehta and Uday Mehta who claim to be the legal heirs of the Property and who have allegedly forged the Property documents and sold it to Raghunandana Tangirala. Subsequently, a criminal case was filed arraying Mr. Raghunandana Tangirala as Accused No.3. in CCNO. 6549 of 2023 on the file of Chief Metropolitan Magistrate Court, Egmore, Chennai.
